### **SUMMARY OF UNAUDITED 2024 THIRD QUARTER FINANCIAL INFORMATION OF A SUBSIDIARY OF THE COMPANY**

This announcement is made by China Conch Environment Protection Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 9 April 2024, 29 July 2024 and 7 August 2024 in relation to the issuance of medium-term notes in the PRC by Anhui Conch Environment Group Co., Ltd.\* (安徽海螺環保集團有限公司) (“**Anhui Conch Environment Group**”), a subsidiary of the Company. From 5 August 2024 to 6 August 2024, Anhui Conch Environmental Group issued the 2024 first tranche green medium-term notes in the PRC.
